How to collect your Brokerage fees?

Held on Feb. 23rd at The Chamber of Commerce, Industry and Agriculture of Beirut and Mount Lebanon. Directed by Lawyer Jean Tabet, REAL Legal Adviser and Mr Nabil Gebrayel REAL, Board Member.

REAL Project of Law

REAL presented the Project of Law to the Lebanese Parliament to regulate the Real Estate Brokerage profession and consumers protection. The Bill prepared by the syndicate was sent by the parliament to the relevant ministries to have their comments before sending it back to the parliament to turn it into law.

The articles in the Bill include: Consumer protection, Intermediaries rights, Requisites to admit members to the syndicate, Loss of membership and dismissal, Pension fund, Council of the Union designations, regulations, brokers entitled fees and financial matters.



Necessary steps to a better market

Significant legislative initiatives often require fixes to address unintended consequences.

REAL will continue defending the real estate sector from the new taxes imposed by the government advising and voicing its concerns to the government and the members of the parliament while stressing on the importance the real estate sector has in the economy. To that effect REAL joined forces with the Chambers of Commerce, headed by Mr. Mohammad Choucair, to devise and propose solutions that will encourage investments in the Lebanese market. REAL advises and stresses on the government to include in its yearly budget an amount to support the housing sector, especially the low-cost houses and the Public Corporation for Housing.

A Window to the law Controversial Rental Law By Lawyer Jean Tabet

The controversial rental law published in the Official Gazette on March 2017,1 that puts an end to old rental agreements has been largely suspended due to the inability of the government to provide monetary compensation from the tenants who are not able to pay the increase on the rental lease decided by the said law.

Under this law, owners can enforce an incremental increase of the rent paid by old tenants and eventually evict them. However, Article 58, protects that rights of tenants whose family nucleus earns less than 2,250\$ (five times the minimum wage) and who therefore cannot be evicted or be subjected to rent increase without receiving government compensation. It is estimated that %50 of the cases fall under this protected category preventing the law to be applied.

Despite the absence of a fund, some of the owners have reached an agreement with their tenants on the estimation of the new rental value after the increase, knowing that these categories are not involved with the Fund to be established by the new law.

By law, owners must compensate the tenants depending on the yearly rental value after the increase, equal to five years in case premises are restituted for family necessities and six years for demolition.




General indicator of the current market

Real Estates Statistics for December 2017, January, February 2018


Number of Sales
